EXPECTED LISTING DATE FOR THE PROPOSED SECONDARY LISTING ON THE SINGAPORE EXCHANGE

This announcement is made by Concord New Energy Group Limited (the “**Company**”, together with its subsidiaries, collectively, the “**Group**”) pursuant to Rule 13.09(2)(a) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) and Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

References are made to the following announcements published on the Stock Exchange (the “**Announcements**”): the announcement of the Company dated 27 February 2025 in relation to the Proposed Secondary Listing on the Main Board of the SGX-ST, the announcement of the Company dated 23 December 2025 in relation to the receipt of the ETL from the SGX-ST, and the overseas regulatory announcement of the Company dated 29 December 2025 in relation to the introductory document. Unless otherwise stated, capitalised terms used herein have the same meanings as those used in the Announcements.

The Board is pleased to announce that subject to the fulfillment of the conditions in the ETL, the Company expects its ordinary shares to be listed and to commence trading on the SGX-ST on 6 January 2026. The ETL is not an indication of the merits of the Proposed Secondary Listing, the Group and/or the Company’s shares.

Pursuant to paragraph 1(d)(ix) of the ETL, the latest price of the Company’s shares listed for trading on the Stock Exchange as at close of market on 5 January 2026 (Hong Kong time) was HK\$0.340 (approximately S\$0.056 per share, based on the exchange rate of S\$1: HK\$6.05 on 5 January 2026).

The Proposed Secondary Listing is subject to, amongst others, the fulfilment of conditions as set out in the ETL and prevailing market conditions. As such, there is no assurance that the Proposed Secondary Listing will proceed to completion. Shareholders and potential investors of the Company are advised to exercise caution when dealing in the securities of the Company.
